- I. The meeting was called to order at 9:10 am by President Lori Frye.
- II. Tina Mohring led a review of the spring business meeting minutes.
  - A. A motion to approve the spring business meeting minutes was made by Michelle Richards (Mount Carmel College of Nursing), a second was made to approve by Annetta Keller (Columbus State Community College). **The motion was carried.**
- III. Jasmine Anderson presented the Treasurer Report.
  - A. Total revenue is 94,000.00 and expense is 49,000.00 but this does not include expenses from the fall conference.
  - B. A motion to approve the Treasurer Report was made by Cory Gadel (Ohio Dominican University), a second to approve was made by Mykilah Lewis (Xavier University). **The motion carried.**
- IV. John Brautigan presented the Membership Report
  - A. There are currently 48 schools paid and 16 business partners paid.

VII. Spring Conference Update by Kim Engle

- A. The spring conference season is so busy so the board decided to switch the two-day conference from spring to fall. This year, there will be a two day conference in spring of 2020 AND fall of 2020. Starting with 2021, the spring conference will be one day.
- B. The spring 2020 conference will be held in Cincinnati at the same location as the spring of 2019. The dates are March 12-13 and the goal will be to have the agenda finalized in December.
